I - INTRODUCTION

On the 15th day of November two thousand and twenty-two, at 10.00 hours, the jury nominated by the CCMAR board of Directors on 07/09/2022, met by video conference, for the third meeting of the call Ref. CCMAR/BINCGAM/29/2022. The meeting was held to analyse and agree on the final outcome of the evaluation of applicants for the position of a Research Fellowship for a holder of a Master Degree (Bolsa de Investigação não conducente à obtenção de grau académico para pessoa com Mestrado) within the project *“Foto-libertação de poluentes e de microplásticos a superfície de plásticos”* reference EXPL/CTAAMB/1613/2021 funded by the Fundação para a Ciência e a Tecnologia (FCT) through the Portuguese national budget. III – CONCLUSION




