I - INTRODUCTION

On the 15th day of November two thousand and twenty-two, at 11.00 hours, the jury nominated by the CCMAR board of directors on 07/09/2022, met by video conference, for the meeting 3 of the call Ref. CCMAR/BM/30/2022. The meeting was held to analyse and agree on the final outcome of the evaluation of applicants for the position of a Master's Fellowship (Bolsa de Mestrado) within the project "Foto-libertação de poluentes e de microplásticos a superfície de plásticos" (reference EXPL/CTAAMB/1613/2021) funded by the Fundação para a Ciência e a Tecnologia (FCT) through national budget under the following conditions. The nominated jury was composed by Professor Doctor Deborah Power, Full Professor at Algarve University and group leader at CCMAR (president of the jury), Doctor João Cardoso, researcher at CCMAR (member) and Doctor Joana Cruz, researcher at CCMAR (member), and had the following agenda items: Decision about the final result following the end of the right of prior hearing of the candidates.
