

## Minute 3

### I - INTRODUCTION

On the fifteen day of November of two thousand and twenty two, at ten hours, the jury nominated by the CCMAR board of Directors on 05/04/2022, met by video conference, for the meeting 3 of the call Ref. CCMAR/BINCGAM/14/2022. The meeting was held for the award of a Research Fellowship for a person with a master's degree (Research grant not conducive to obtaining an academic degree for a person with a master's degree) through the project with reference **PRIMA/0002/2019** – “*Development and Optimization of Halophyte-based Farming systems in salt-affected Mediterranean Soils.*” funded by Fundação para a Ciência e a Tecnologia, I.P./MCTES through National budget and PRIMA.
