I - Introduction

On 24th day of the month of March, two thousand and twenty-three, at 10 hours, the jury nominated by the CCMAR board of Directors on 20-01-2023, met by videoconference, for the second meeting of the call Ref. CCMAR/TSI/02/2023. The meeting was held for the award of a vacancy for a Research Technical Officer (Técnico/a Superior de Investigação) (M/F), in the field of Marine Biology to satisfy temporary needs under an uncertain term employment contract in order to support the work carried in the context of the research project with reference: EXPL/BIA-BMA/0682/2021- "microCOOL: tampão térmico endossimbiótico microbiano contra ondas de calor." funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funding (PIDDAC). The nominated jury was composed by Dr. Gerardo Zardi, Coordinator of the project and researcher at CCMAR (president of the jury), Dr. Katy Nicastro, researcher at CCMAR (Member) and Dr. Regina Cunha, researcher at CCMAR (member) and had the following agenda items: admission and evaluation of applications admitted to the position CCMAR/TSI/02/2023.

II - Candidates

III – Admission and Evaluation of applications

The eight candidates who applied were admitted to the evaluation and ranking phase (Table 1). The Jury evaluated the application documents of the eligible candidates, and applied the

classification criteria and the respective weightings set out in the notice of opening of the call, as shown in table 1 below:

- 2. Knowledge of written and spoken English (5%)
- 3. Previous molecular experience (25%)
- 4. Previous experience in manipulative field intertidal experiments (15%)
- 5. Previous experience with working in the microbial communities (5%)

V - Conclusion

The candidates obtained a final classification between 88 and 54 points (Table 1), with the candidate Luana Santos Corona having the highest classification (88 points; Table 2).

Considering the elements presented, the candidate Luana Santos Corona gathers conditions for the purposes of eventual selection, so the jury proposes the ratification of this decision to the CCMAR Board.

The Jury will proceed to the right of prior hearing of the candidates, setting a deadline of 10 working days to claim what they consider to be convenient, whether in relation to scientific or procedural matters.
