I - Introduction

On the nineteen day of September two thousand and twenty-two, at 09:00 hours and 30 minutes, the jury nominated by the CCMAR board of Directors on 15/05/2022, met by video conference, for the meeting 3 of the call Ref. CCMAR/BIC/15/2022. The meeting was held for the award of Research Fellowships (Scientific Initiation Fellowship – BIC) through the research project MARAFRICA "A network monitoring, integrating and assessing marine biodiversity data along the west Africa to understand, predict and mitigate climatic / oceanographic changes." reference no 540316524 funded by Aga Khan, Network for Development and the Portuguese Foundation for Science and Technology, I.P..
