International call for two (2) Scientific Initiation Fellowship (BIC) for persons with a Bachelor Degree, within the scope of the research project: "Aplicação de Tecnologias Inovadoras e Sustentáveis de Processamento e de Monitorização de Qualidade de Produtos Alimentares do Mar" reference MAR-01.03.01-FEAMP-0050 cofunded by the Operational Programme Mar 2020, Portugal 2020 and the Europen Union through the European Fund for Maritime Affairs and Fisheries.

I - Introduction

On the 29 day of October, two thousand and twenty-one, at 14:00 h pm, the nominated Jury for the call with reference CCMAR/BINCGA/09/2021, gathered through the Zoom platform, for the allocation of the two fellowships for persons with a Bachelor Degree (Bolsa de Iniciação á Investigação Científica) within the research project: "Aplicação de Tecnologias Inovadoras e Sustentáveis de Processamento e de Monitorização de Qualidade de Produtos Alimentares do Mar" reference MAR-01.03.01-FEAMP-0050 cofunded by the Operational Programme Mar 2020, Portugal 2020 and the Europen Union through the European Fund for Maritime Affairs and Fisheries. The jury, composed by Dr. Liliana Anjos Guerreiro, auxiliary researcher at UALG/CCMar (president), Professor Dr. Deborah Power group leader and full professor at UALG/CCMar (member), and Dr. Patrícia Pinto auxiliary researcher at UALG/CCMAR (member) had the following points of the agenda: admission and evaluation of applications admitted to the call CCMAR/BIC/09/2021.

II - Candidates

4 applications were received for the position:

III - Exclusion of applications

The jury analysed the applications, considering the mandatory documents and the requirements, and decided to exclude 1 candidate (Table 1), for the following reasons:

Table 1. Candidates excluded of the evaluation and ranking phase.

Candidate Farhat Un Nisa Bajwa does not have a bachelor's degree and has not delivered a copy of the Bachelor degree Certificate (if awarded by a Portuguese Higher Education Institution) or a copy of the certificate of recognition of the Bachelor degree by a Portuguese Public Higher Education Institution or by DGES — Directorate General for Higher Education (if the degree was awarded by a foreign University).

Thus, 3 candidates were admitted to the evaluation and ranking phase (Table 2).

IV - Evaluation of applications

The Jury evaluated the application documents of the eligible candidates (Table 2) and applied the classification criteria and weighting factors set out in the vacancy announcement as shown in Table 3 below:

Evaluation criteria and respective weighting:

- Proven experience in molecular biology techniques that support microbiome analyses and validation, mainly in DNA/RNA extraction, quality control and quantification; PCR and quantitative PCR; cloning; microbiological techniques (liquid and solid microbial cultures); bioinformatics analysis of sequences (sequencing, alignments and comparison to databases) and bioinformatics analysis of metagenomics data – 35%
- Proven experience in molecular biology activities that support protein analysis, mainly techniques for
 protein extraction, quantification, gel electrophoresis and staining; purification (continuous elution
 electrophoresis/chromatography); biophysics (CD and fluorescence); immunoassays and histological
 techniques (dot blot, Western blot, ELISA, histology and immunohistochemistry); bioinformatics analysis
 (sequence and database searches) 35%
- Work experience in a scientific research laboratory (minimum 6 consecutives months) 15%
- Familiarization with fish tissue samples manipulation and management (high numbers/storage conditions/labelling) – 10%
- Motivation in the field of study related to the work plan 5%

Note: The final grades in Table 3 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from 0 to 20V.

Table 4 presents the overall classification in order of rank.

V - Conclusion

The candidates obtained a final classification between 7.20 and 14.35 values (Table 4), with the candidates Patrícia Isabel Lopes Lima and Guilherme Alexandre Alves Russo having the highest classification (14.35 and 13.30 values respectively; Table 4)

Considering the presented elements, the candidates Patrícia Isabel Lopes Lima and Guilherme Alexandre Alves Russo meets the conditions for the purposes of eventual selection, so the Jury proposes the ratification of this decision to the CCMAR Board.

The Jury will proceed to the right of prior hearing of the candidates, setting a deadline of 10 working days to claim what they consider to be convenient, whether in relation to scientific or procedural matters.

With no other item on the agenda, the meeting of which these minutes were drawn up was closed, with 3 pages, and annex, which after being read and approved were signed by the members of the jury.
