I - Introduction

On 13th day of the month of April, two thousand and twenty-three, at 10 hours, the jury nominated by the CCMAR board of Directors on 20-01-2023, met by videoconference, for the third meeting of the call Ref. CCMAR/TSI/02/2023. The meeting was held for the award of a vacancy for a Research Technical Officer (Técnico/a Superior de Investigação) (M/F), in the field of Marine Biology to satisfy temporary needs under an uncertain term employment contract in order to support the work carried in the context of the research project with reference: EXPL/BIA-BMA/0682/2021- *“microCOOL: tampão térmico endossimbiótico microbiano contra ondas de calor.”* funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funding (PIDDAC). The nominated jury was composed by Dr. Gerardo Zardi, Coordinator of the project and researcher at CCMAR (president of the jury), Dr. Katy Nicastro, researcher at CCMAR (Member) and Dr. Regina Cunha, researcher at CCMAR (member) and had the following agenda items: decision about the final results following the end of the right of prior hearing of the candidates.

II – Claims

After the communication of the provisional results on the 27-03-2023, no claims were received during the period of prior hearing of the candidates.

III – Conclusion


