#### **I – Introduction**

On the eighth day of November two thousand twenty-three, at fifteen hours the jury nominated by the CCMAR board of Directors on 09/08/2023, met by video conference, for the third meeting of the call Ref. CCMAR/BD/13/2023. The meeting was for the hiring of a Doctoral fellowship (Bolsa de Doutoramento) for the project ref. C644915664-00000026 - PRR: Pacto Bioeconomia Azul - Vertical Algas (WP 5 - subprojeto AlgalFeeds) funded by PRR - Plano de Recuperação e Resiliência. The nominated jury was composed by Doctor Sofia Engrola, coordinator of the project at CCMAR, researcher and team leader at CCMAR (president of the jury); Doctor Rita Teodósio, researcher at CCMAR (member) and Prof. Dr. Juan Antonio Martos-Sitcha, Professor at UCA (member) and had the following agenda items: decision on the final results after the end of the right of prior hearing of the candidates.

#### **II – Claims**

The communications of the provisional results were sent to all the candidates on 23/10/2023. During the period of prior hearing a claim was received from Doctor Soheil Bahrebar on October 23rd at 11:39 asking for the reassessment of his application.

The selection committee decided to reassess Doctor Bahrebar's application and reanalyzed all the information/documents submitted by Doctor Soheil Bahrebar at the time of the application and unanimously has decided to maintain the previous scores as follow in table 1:
