

Minute 3 ATA N.º 3 CCMAR/BINCGAM/15/2023

I - Introduction

On the 25th day of October two thousand and twenty-two, at 17 hours and 00 minutes, the jury nominated by the CCMAR board of Directors on 04/09/2023, met by video conference, for the third meeting of the call Ref. CCMAR/BINCGAM/15/2023. The meeting was held to analyse and agree in the final outcome of the evaluation of applicants for the position of a Research Fellowship for a person with a Master Degree (Bolsa de Investigação não conducente à obtenção de grau académico para mestre), within the project ref. 2022.08563.PTDC: INNATEMEM - Harnessing innate immune training for enhanced disease response in marine bivalves - funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funding (PIDDAC). The nominated jury included Professor João Cardoso, Lecture at Algarve University and researcher at CCMAR and coordinator of the project (President); Professor Deborah Power, Full Professor at Algarve University and group leader at CCMAR (member) and Doctor Rute Castelo Félix, researcher at UALG and CCMAR (Member) and had the following agenda items: decision on the final results after the end of the right of prior hearing of the candidates.

II - Claims

The communications of the provisional results were sent to all the candidates on 10/10/2023. During the period of prior hearing no claims were received.

III - Conclusion
