I – Introduction

On the twenty-four day of November of two thousand twenty-three, at eleven hours the jury nominated by the CCMAR board of Directors on 09/08/2023, met by video conference, for the fourth meeting of the call Ref. CCMAR/BD/13/2023. The meeting was for the hiring of a Doctoral fellowship (Bolsa de Doutoramento) for the project ref. C644915664-00000026 - PRR: Pacto Bioeconomia Azul - Vertical Algas (WP 5 - subprojeto AlgalFeeds) funded by PRR - Plano de Recuperação e Resiliência. The nominated jury was composed by Doctor Sofia Engrola, coordinator of the project at CCMAR, principal researcher and team leader at CCMAR (president of the jury); Doctor Rita Teodósio, researcher at CCMAR (member) and Prof. Dr. Juan Antonio Martos-Sitcha, Professor at UCA (member) and had the following agenda items: decision on the final results after the non-acceptance of the candidate Morgana Angelo.

II- Jury decision:


After the communication of the final results on November 15th 2023, the jury received an email on November 22nd from the candidate ranked 1st, Morgana Angelo, informing that she has decided not to accept the position. Due to this information the jury has unanimously decided to assign the doctoral fellowship to the next applicant in accordance with the ranking positions based on the selectable reservation list.


