#### I - Introduction

On the 11th day of May two thousand and twenty-six, at 15 hours, the jury nominated by the CCMAR board of Directors on 14-04-2026, met by videoconference, for the meeting 2 of the call Ref. CCMAR/TSI/05/2026. The meeting was held for the award of 2 (two) positions of Research Technician (Técnico/a Superior de Investigação) (M/F) to meet temporary needs under an uncertain employment contract. The positions will support the work carried out in the context of the of the project Ref. MPr-2023-12-16551 (ALGARVE-FEDER-00772500), entitled AdaptKelp – “*Securing a sustainable future for the aquaculture of Laminaria ochroleuca*”, funded by the Portuguese Foundation for Science and Technology (FCT). The nominated jury present at the meeting was composed by Doctor Neusa Martins, project coordinator, Auxiliary Researcher and co-Group Leader at CCMAR (President of the Jury); Doctor Gareth Pearson, co-Group Leader and Principal Investigator at CCMAR (full member); Doctor Luís Barreto, Junior Researcher at CCMAR (full member) with the following agenda: admission and assessment of the applications received to the position CCMAR/TSI/05/2026.

#### IV – Admission and Evaluation of applications

10 candidates were not admitted to the evaluation phase (**Table 1**) due to failure in meeting one or more requirements stated in the official announcement, as follows:

1. Bachelor’s degree in Marine Biology or related fields;
2. Fluency in English, both written and spoken;
3. Experience in kelp cultivation;
4. Experience in the field of kelp ecology, biology and reproduction;
5. Experience in light microscopy and image analysis techniques (machine learning – FIJI, deep learning).

And/or failure in submitting all documents/information required in the official announcement, as follows:

1. Motivation letter in English.
2. Detailed CV in English.
3. Copy of the Bachelor’s degree certificate.
4. Email contacts of up to three references.

## V - Evaluation of applications

The Jury evaluated the application documents of the eligible candidates (**Table 2**) and applied the classification criteria and weighting factors set out in the vacancy announcement as shown in **Table 3** below:

**Evaluation criteria and respective weighting:**

1. Proven experience in kelp cultivation - 40%
2. Proven experience in the field of kelp ecology, biology and reproduction- 40%
3. Proven experience in light microscopy and image analysis techniques (machine learning – FIJI, deep learning )– 20%

Note: The final grades in table 3 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from **0** to **20**, rounded to the nearest tenth.

The present recruitment procedure aims to hire two (2) individuals to meet temporary needs, with the positions being filled by the candidates ranked in the first two places on the final ranking list approved by the selection committee.

Table 4 presents the Classification and Ranking.

**V – Conclusion**

The candidate **Julia Soares Aguiar** obtained a final classification 18.8 points (out of a total of 20) and candidate **Benjamim de Oliveira Marques Portugal** obtained a final classification of 18.6 points (out of a total of 20).

Considering the elements presented, candidates **Julia Soares Aguiar and Benjamim de Oliveira Marques Portugal** gathers conditions for the purposes of eventual selection, so the jury proposes the ratification of this decision to the CCMAR Board.

The jury will proceed to the right of prior hearing of all the candidates, setting a deadline of 10 working days to claim what they consider to be convenient, whether in relation to scientific or procedural matters.
