I- Introduction

On the 8th of July of two thousand twenty-six, at 10 hours and 30 minutes, the jury nominated by the CCMAR board of Directors on 16/06/2026, met by video conference, for the second meeting of the call Ref. CCMAR/BM/09/2026. The meeting was for the hiring of a Master's Fellowship (Bolsa de Mestrado), for applicants of any nationality, including stateless candidates, and holders of political refugee statute, in the scientific field of Biology, Ecology and Analytical Chemistry within the research project number **2024.04866.RESTART** - named as **PROCOAST**: "*Producers & Toxicity Assessment of Tetrodotoxin and analogues on the Portuguese Coast*", funded by the Foundation for Science and Technology (FCT) under the RESTART Programme 2nd edition. The jury present at the meeting was composed by Doctor Sandra Lage, Group leader at CCMAR, Coordinator of the project, Invited Assistant Professor at University of Algarve and Auxiliary Researcher at CCMAR (President); Doctor Ana Catarina Braga, Researcher at S2AquaColab (Member) and Doctor José Paulo da Silva, Researcher at CCMAR Analytical Services Platform (Member) and had the following agenda items: admission and evaluation of the applications admitted to the position CCMAR/BM/09/2026.

V - Evaluation of applications

Evaluation criteria and respective weighting:

1. Proven experience in EURLMB Standard Operating Procedures for Determination of Tetrodotoxin and Liquid Chromatography-High Resolution Mass Spectrometry (LC-HRMS) (30%);
2. Proven experience in LC-HRMS data analysis using Thermo Scientific Xcalibur software and R (30%);
3. Proven experience in the isolation and purification of compounds using preparative liquid chromatography (30%);
4. Good knowledge of written and spoken English (5%);
5. Previous communications in conferences of the Fellowship research topic (5%).

Note: The final grades in table 3 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from 0 to 20, rounded to the nearest tenth.
